The Knights of Columbus has announced some enhancements in its Long Term Care Plans. These enhancements took effect on February 1, 2008 and are now available. The age limit at which you can now apply for a plan has been lowered to 30. Although you may not consider something like having long term care coverage a priority at this age group, premiums can be very economical and the cost of waiting to buy at a later time can be significant. Accidents and health changes can come to the young as well as to the older person and this could make you ineligible for coverage. The second change that applies to all is an increase in the daily benefit from \$250 to \$400. Those who already hold long term care plans can apply for the higher daily benefit.
